

## 2021/22 MEMBERSHIP

These Membership Terms (Terms) govern the application for Women's Network Australia Individual, Silver Circle and Platinum Membership (Membership). It is your responsibility to review these Terms prior to your application for Membership. By applying for Membership you agree to be bound by these Terms. We reserve the right to amend these Terms at any time, and will provide the most recent version on our website.

Throughout these Terms, the terms "Women's Network Australia", "we", "us" and "our" refer to Women's Network Australia Pty Ltd and its associated entities, and "you" refers to the individual or business purchasing Membership.

### APPLICATION FOR MEMBERSHIP

1.1 Our current Membership descriptions, entitlements and pricing will always be stated on our website located at <https://www.womensnetwork.com.au/membership>

1.2 All applications for Membership must be made by filling out the form on our Website. This will create a membership account for you.

1.3 All information you provide during the application process must be accurate and complete, and it is your responsibility to keep your details up to date.

1.4 We will only process completed applications, and reserve the right to reject an application for any reason.

1.5 It is solely your responsibility to maintain the confidentiality of any password you create for accessing your account.

1.6 We will send you a confirmation email on payment of the applicable Membership Fee. Your Membership is deemed accepted on the day you receive the email.

### MEMBERSHIP FEES

2.1 The Membership Fee may be paid by either:  
2.1.1 A single upfront annual payment via credit card, Zippay, Paypal or our payment gateway, Stripe; or  
2.1.2 Electronic Funds Transfer; or  
2.1.3 Payment over telephone.

2.2 We may increase the Membership Fee from time to time. If we do so, we will give you at least one month's notice of the intended increase by email and by notice on our Website.

2.3 Minimum commitment is 12 months from initial joining date. If paying annually, your fees are non-refundable if you wish to cancel your membership early.

2.4 As a Premium Member you have access to a range of member benefits which will change from time to time.

### AUTO RENEWAL

3.1 If you pay annually, your Membership will be automatically renewed each year, on the anniversary of the date you joined Women's Network Australia (Anniversary) unless you wish to terminate your membership subscription.

3.2 The Membership Fee for the forthcoming year will be charged to the same credit card you used on joining, unless you specify otherwise.

3.3 If you wish to terminate your Membership, you must give notice at least five days prior to the Anniversary. If we do not receive notification from you, your Membership will be auto-renewed and the applicable Membership Fee payable.

### REFUNDS

4.1 The Membership Fee is not refundable.

4.2 Women's Network Australia may offer a refund in special circumstances on a case-by-case basis.
