APPLICATION FOR MEMBERSHIP

- Applications must be completed via the WNA Website.
- All information provided must be accurate and kept up to date.
- WNA reserves the right to accept or reject any application.
- You are responsible for maintaining the confidentiality of your account password.
- Membership is confirmed upon receipt of payment and confirmation email from WNA.

MEMBERSHIP FEES & PAYMENT

- Membership fees must be paid annually in advance, via:
 - Credit or debit card
 - Stripe or PayPal
 - Electronic Funds Transfer (EFT)
- Fees are non-refundable except as required under the Australian Consumer Law (ACL).
- Membership terms are 12 months from the date of joining.
- Members will be notified at least one month in advance of any fee increases.
- Renewal notices are issued at the end of each term. Members must notify WNA at least five (5) days prior to the renewal date if they do not wish to continue.
- Memberships renew automatically unless cancelled in writing before the renewal date.

- These Terms are governed by the laws of Queensland, Australia.
- Any disputes will be resolved in the courts of Queensland.

- WNA does not guarantee the continued availability of any specific benefit.
- Benefits are provided for the exclusive use of the registered member and are non-transferable

- Personal information is handled in accordance with our Privacy Policy.
- Members consent to:

 - Receiving communications from WNA and approved partners, with the option to unsubscribe at any time.
- WNA may photograph or record events. Attendance implies consent to use your image and voice in promotional materials without compensation.
